
A Celebration and Installation of 26 Fallen Angels During Black History Month

EDITOR'S NOTE: The article below is taken from the *African-American* Historical News Journal: 178 Years of Our Country's History as Documented by Historical Newspaper Articles. It reports the justification for Black American descendants of Slaves to receive reparations today in contrast to the testimony of pro-football great Herschel Walker winner of the 1982 Heisman Trophy who told a House Judiciary subcommittee that he opposes reparations for slavery on a number of grounds including his religion, according to Susan Jones reporting for CNSNews.com. The hearing which was focused on H.R. 40, legislation introduced by Rep. Sheila Jackson Lee (D-Texas), was to seeks to address the fundamental injustice, cruelty, brutality, and inhumanity of slavery in the Unites States and the 13 American colonies between 1619 and 1865 and to establish a commission to study and consider a national apology and proposal for reparations for the institution of slavery, its subsequent de jure and defacto racial and economic discrimination against African Americans, the impact of these forces on living African-Americans, to make recommendations to the Congress on appropriate remedies, and for other purposes, reported Jones. African American descendants of slaves have never been fully repaired from the breach of wrongful acts from the government of the United States.


Amid Alarming Audit Findings, Legislators Introduce Bipartisan Measure to Increase Oversight of State Homeless Funding

Legislation Follows Highly Critical Report by the California State Auditor; Would Require Providers to Report Key Data and Metrics as a Condition of Receiving State Funding

Introduction Follows Veto Last Year by Governor Newsom of Similar Legislation that Passed the Legislature with Unanimous Bipartisan Support

Today, Assemblymember Jesse Gabriel (D-Woodland rightly notes, we need more Hills), along with seven bipar- accountability, transparency, tisan co-authors, introduced legislation that would provide stronger oversight, transparency, and accountability for state homelessness funding.

Most significantly, Assembly Bill (AB) 977 would mandate that recipients of state homelessness funding report key data and metrics through the state's Homeless Manage-Information System (HMIS), thereby allowing policymakers to better track and evaluate the effectiveness of various programs around the state. "There is immense frustration in the Legislature and around the state with the lack of progress on homelessness," said Assemblymember Gabriel. "No matter how wellintentioned, we can't keep writing blank checks and hoping for the best.



We need stronger oversight to hold local programs accountable and ensure that public resources are being spent in the most efficient and **SACRAMENTO**, **CA** effective manner possible.

> AB 977 follows the release last week of a highlycritical report by State Auditor Elaine M. Howle, which called the State's approach to homelessness "uncoordinated" and "disjointed" and highlighted that California "continues to lack a comprehensive understanding of its spending to address homelessness, the specific services the programs provide, or the individuals who receive those services."

> Notably, the Audit specifically recommends the approach taken by AB 977, which it argues will "ensure that the State has access to comprehensive data about

homelessness," and provide desperately-needed insight into various homelessness programs and strategies, thereby policymakers enabling to craft better solutions to this worsening crisis.

Among other findings, the Audit notes that despite spending \$13 billion over the past three years, California continues to have the largest homeless population in the nation, with over 151,000 Californians experiencing homelessness in 2019.

Moreover, "[a]t least nine state agencies administer and oversee 41 different programs that provide funding to mitigate homelessness, yet no single entity oversees the State's efforts or is responsible for developing a statewide strategic plan." The introduc-tion of AB 977 follows Governor Newsom's veto last year of AB 2746 (Gabriel), a similar measure that passed both houses of the Legislature with unanimous bipartisan support.

AB 977 is expected to be heard in committee in the coming weeks.

But our people helped to build this country. We have toiled on her rich earth and in her cities for 200 years. America: Give each freedman a plot of earth so he can toil for himself!

We have learned that only by unending agitation and struggle can we achieve our ends. In the words of Frederick Douglass: "...a people too spiritless to defend themselves ... are not worth defending and are not worthy to defend anything else."
